Kawm: California txoj cai hais txog kev ruaj ntseg ntawm Firearms

Nyob zoo cov niam txiv thiab cov neeg saib xyuas:

Lub hom phiaj ntawm correspondence no qhia thiab nco ntsoov qhia cov niam txiv thiab cov neeg saib xyuas raws li txoj cai ntawm tag nrho cov me nyuam kawm ntawv hauv lub Evergreen Npe Tsev Kawm Ntawv ntawm lawv lub luag hauj lwm kom firearms tawm hauv ob txhais tes ntawm cov me nyuam raws li txoj cai. Muaj ntau xov xwm ntaub ntawv qhia txog cov me nyuam nqa firearms rau tsev kawm ntawv. Muaj ntau zaus, tus me nyuam tau txais lub firearm (s) los ntawm nws lub tsev. **Cov pub leej twg yuav yooj yim tiv thaiv los ntawm storing firearms nyob rau hauv ib txoj kev ruaj ntseg thiab ruaj ntseg manner, xws li kom lawv muab tub thaum tsis siv thiab storing lawv nyias nyias los ntawm ammunition.**

Pab sawv daws to taub lawv lub luag hauj lwm raws li txoj cai, no correspondence spell tawm California txoj cai hais txog qhov cia firearms. Thov muab ib co sij hawm los ntsuam xyuas qhov correspondence thiab soj ntsuam koj tus kheej xyaum kom paub tseeb tias koj thiab koj tsev neeg muaj raws li txoj cai California txoj cai lij choj.

- Muaj tsawg kawg nkaus, California ua ib tug neeg txhaum cai rau kom txhua firearm, loaded los yog unloaded, tsis pub dhau tej premises uas muaj nyob rau hauv lawv tus me nyuam thiab tswj qhov twg tus neeg paub los yog reasonably yuav tsum paub tias ib tug me nyuam yuav nce mus saib tau lub firearm tsis tso cai rau tus me nyuam niam txiv los yog tus saib xyuas raws li txoj cai, thiab tus me nyuam tau txais kev pab mus saib tau rau ntawm lub firearm thiab muaj (1) ua rau tuag los yog raug mob rau tus me nyuam los yog lwm tus neeg; (2) yog lub firearm tua cov chaw premises los yog rau ib qhov chaw pej xeem, nrog rau cov me nyuam kawm ntawv qib kindergarten mus txog qib kaum-ob, los yog mus rau tej lub tsev kawm ntawv uas txhawb kev txhawb, kev ua ub no; (3) unlawfully brandishes lub firearm rau lwm tus.¹
- **Faj Seeb:** Lub txim txhaum plaub yuav muaj teeb meem loj dua yog hais tias ib tug neeg xyuas los yog raug kev txom nyem zoo kawg thiab raug mob vim yog tus me nyuam nkag mus rau hauv lub firearm.



- Muaj txwv tsis pub ntxiv, California kuj ua rau nws ib qhov kev ua txhaum rau ib tug neeg negligently khw los yog tawm hauv tej firearm, loaded los yog unloaded, rau lawv premises nyob rau hauv ib qhov chaw uas tus neeg paub los yog reasonably yuav tsum paub tias ib tug me nyuam yuav nce mus saib nws tsis tau tso cai rau tus me nyuam niam txiv los yog tus saib xyuas raws li txoj cai, Tshwj tsis yog tsim nyog yuav tsum ruaj ntseg lub firearm tiv thaiv tsis tau tus me nyuam, txawm tias qhov twg ib tug menyuam **yaus yeej tsis** tau accesses lub firearm.²
- Ntxiv rau tej nplua thiab cov ntsiab lus uas raug kaw, raws li lub ib hlis ntuj 1, 2020, ib rab phom nyob criminally liable nyob rau hauv cov kev cai California ib sab txwv los ntawm possessing, tswj, owning, tau txais, los yog muas ib firearm rau 10 xyoo.³
- Thaum kawg, ib tug niam txiv los yog tus saib xyuas tej zaum kuj yuav civilly rau kev puas tsuaj los ntawm tus neeg raug tus mob firearm los ntawm tus neeg ntawd tus me nyuam los yog ward.⁴

Faj Seeb: Koj lub county los yog lub nroog tej zaum yuav muaj txwv tsis pub muaj kev ruaj ntseg ntawm firearms.

Ua tsaug rau koj pab kom peb cov me nyuam thiab cov tsev kawm ntawv muaj kev ruaj ntseg zoo. Nco ntsoov tias qhov yooj yim thiab kev ruaj ntseg ua raws li txoj cai yog kom firearms nyob rau hauv ib lub thawv uas muaj ib tug locking ntaus ntawv uas renders lub firearm inoperable.
