

**EVERGREEN UNION SCHOOL DISTRICT
RESOLUTION #3-23/24
RESOLUTION ON
SUFFICIENCY OF INSTRUCTIONAL MATERIALS**

WHEREAS, the governing board of the Evergreen Union School District, in order to comply with the requirements of Education Code Section 60119, held a public hearing on August 22, 2023 at five o'clock, which is on or before the eighth week of school, and did not take place during or immediately following school hours, and;

WHEREAS, the governing board provided at least ten days notice of the public hearing posted in at least three public places within the district that stated the time, place, and purpose of the hearing, and;

WHEREAS, the governing board encouraged participation by parents, teachers, members of the community, and bargaining unit leaders in the public hearing, and;

WHEREAS, information provided at the public hearing and to the governing board at the public meeting detailed the extent to which textbooks and instructional materials were provided to all students, including English learners, in the district, and;

WHEREAS, the definition of "sufficient textbooks or instructional materials" means that each pupil has a textbook or instructional material, or both, to use in class and to take home, and;

WHEREAS, sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to academic content standards and consistent with the cycles and content of the curriculum frameworks in the following subjects:

- Mathematics – see attached list;
- Science - see attached list;
- History-social science - see attached list; and
- English/language arts, including the English language development component of an adopted program - see attached list.

WHEREAS, sufficient textbooks or instructional materials were provided to each pupil enrolled in foreign language or health classes, and;

THEREFORE, IT IS RESOLVED that for the 2023/2024 school year, the Evergreen Union School District has provided each pupil with sufficient textbooks and instructional materials aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks.

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of the Evergreen Union School District hereby authorizes Superintendent Brad Mendenhall to carry out the purpose of this resolution.


